### Notice under Section 708A(5)(e) of the Corporations Act 2001 (Cth)

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Act**), Manuka Resources Limited (**ASX: MKR; NZX: MKR**) (**Company**) gives notice to ASX of the issue of 5,445,897 fully paid ordinary shares (**Shares**) following the exercise of 5,445,897 options exercisable at \$0.06 with an expiry date of 15 May 2026.

The Shares were issued without disclosure to investors under Part 6D.2 of the Act.
