**Notice pursuant to regulation 49G(2)(e) of the Financial Markets Conduct Regulations 2014**

Infratil Limited (**Infratil**) gives notice under regulation 49G(2)(e) of the Financial Markets Conduct Regulations 2014 (**Regulations**) that it proposes to make an offer (**Offer**) for issue of unsecured, subordinated, repayable, cumulative, interest-bearing capital bonds maturing on 15 June 2057 (**Capital Bonds**).

The Offer will be made using short-form disclosure as the Capital Bonds will rank in priority to Infratil's existing ordinary shares quoted on the NZX Main Board under the ticker code IFT ("**Ordinary Shares**").

As at the date of this notice, Infratil is in compliance with:

- the continuous disclosure obligations that apply to it in relation to the Ordinary Shares; and
- its financial reporting obligations (as defined in Regulation 49H(7) of the Regulations).

As at the date of this notice, there is no information that is "excluded information" that is required to be disclosed for the purposes of regulation 49H(2)(e) of the Regulations.
