What is the purpose of this update?

This document tells you how the Smart Global Aggregate Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

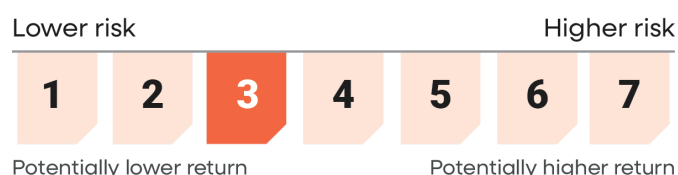
The Smart Global Aggregate Bond ETF is designed to track the return (before tax, fees and other expenses) of the Bloomberg Global Aggregate Total Return Index Hedged NZD. The Index is comprised of global investment grade

bonds. The currency exposure is hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Smart Global Aggregate Bond ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

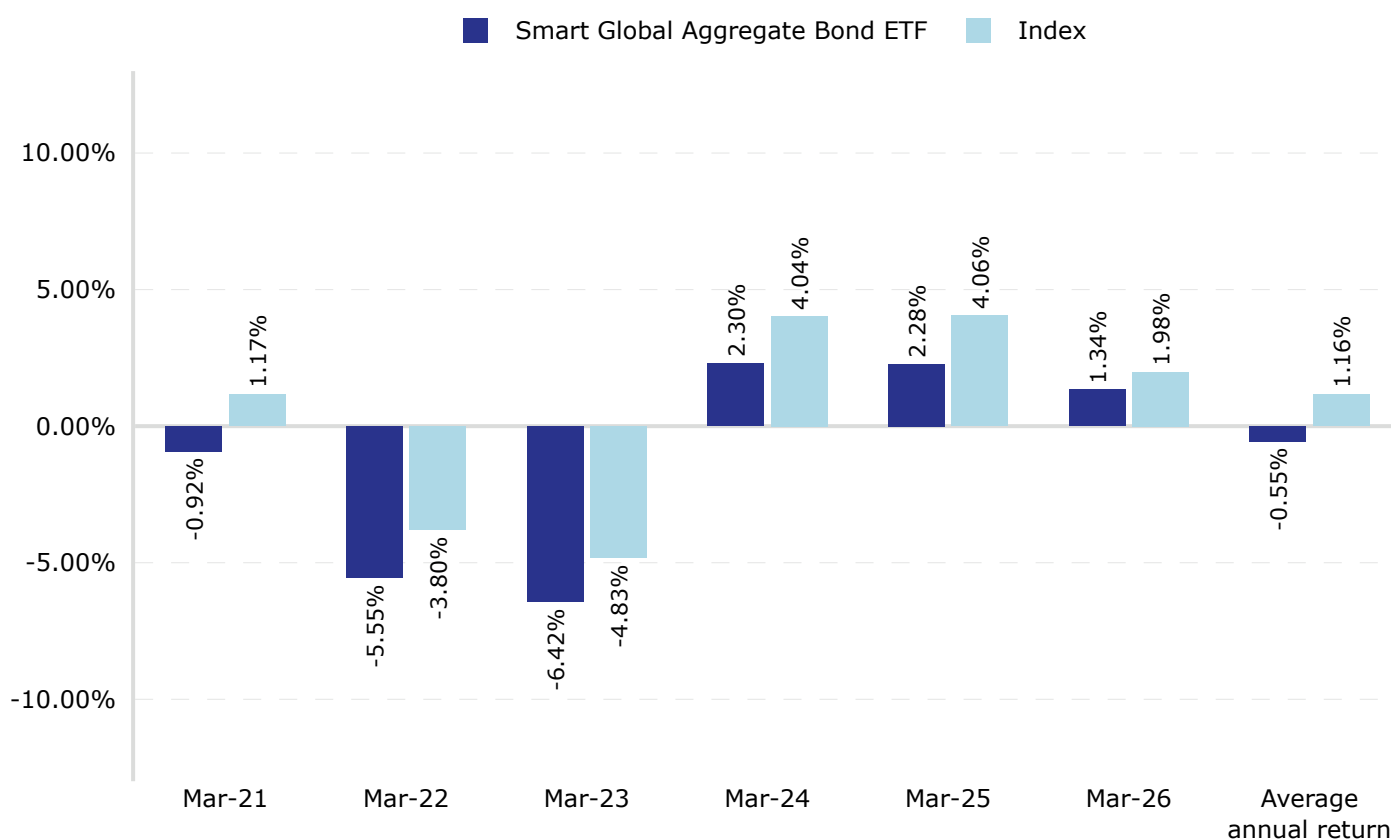

How has the fund performed?

What fees are investors charged?

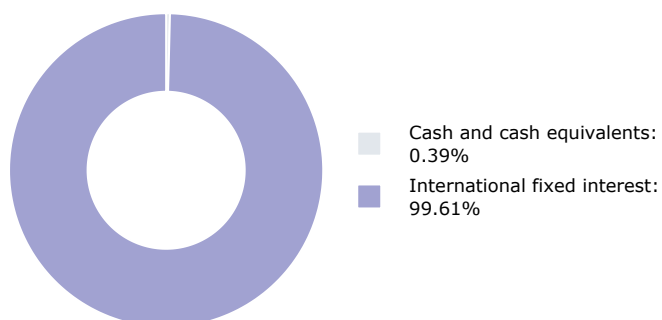
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$165 (that is 1.65% of Tara's initial \$10,000). This gives Tara a total return after tax of \$155 for the year.

The Smart Global Aggregate Bond ETF invests in the iShares Core Global Aggregate Bond UCITS ETF NZD Hedged (Acc), which hedges foreign currency exposure to the New Zealand dollar.
