What is the purpose of this update?

Description of this fund

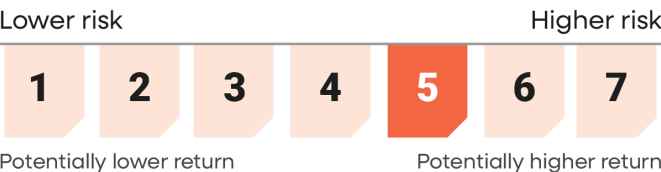
The Smart Europe ESG ETF is designed to track the return (before tax, fees and other expenses) of the MSCI Europe Screened Index. The Index is comprised of European companies screened for exposure to controversial weapons, civilian firearms, tobacco, thermal coal and oil sands. The Index excludes companies that fail to comply with

What are the risks of investing?

Risk indicator for the Smart Europe ESG ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

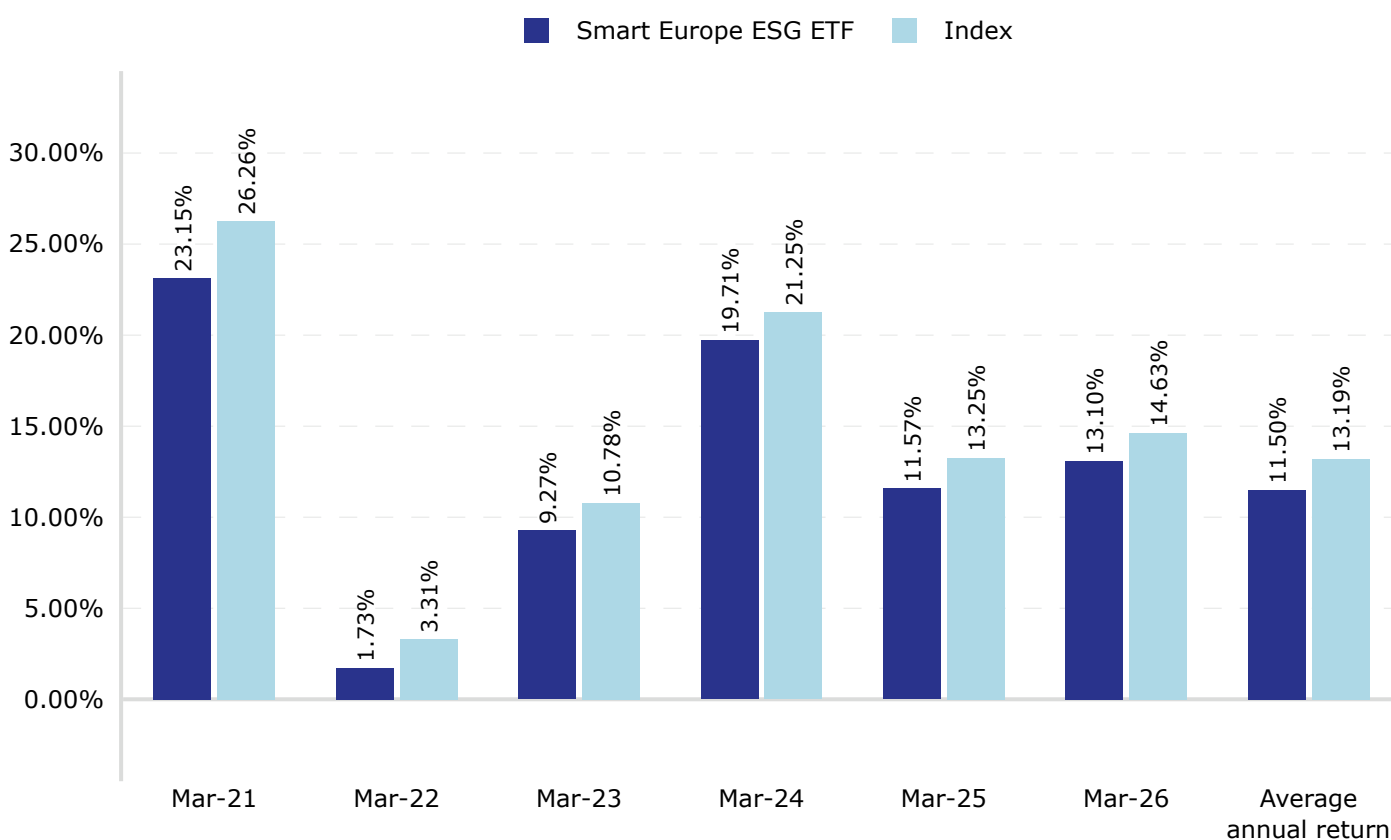

How has the fund performed?

What fees are investors charged?

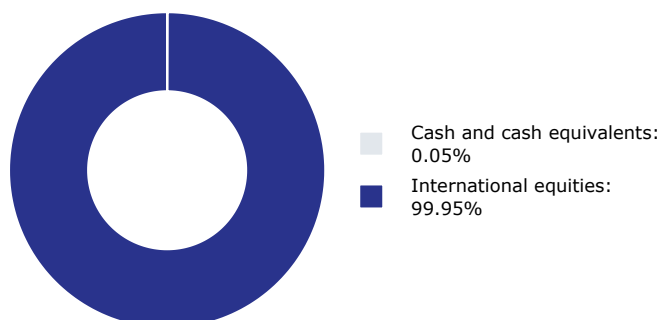
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,453 (that is 24.53% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,296 for the year.
