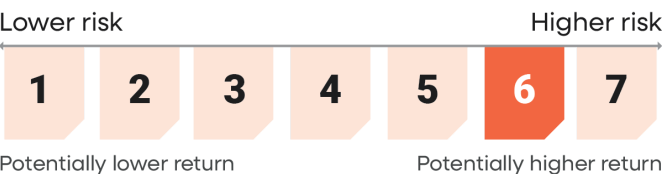
Description of this fund

The Smart Gold ETF invests in the iShares Gold Trust and seeks to reflect generally the performance of the price of gold.

What are the risks of investing?

Risk indicator for the Smart Gold ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

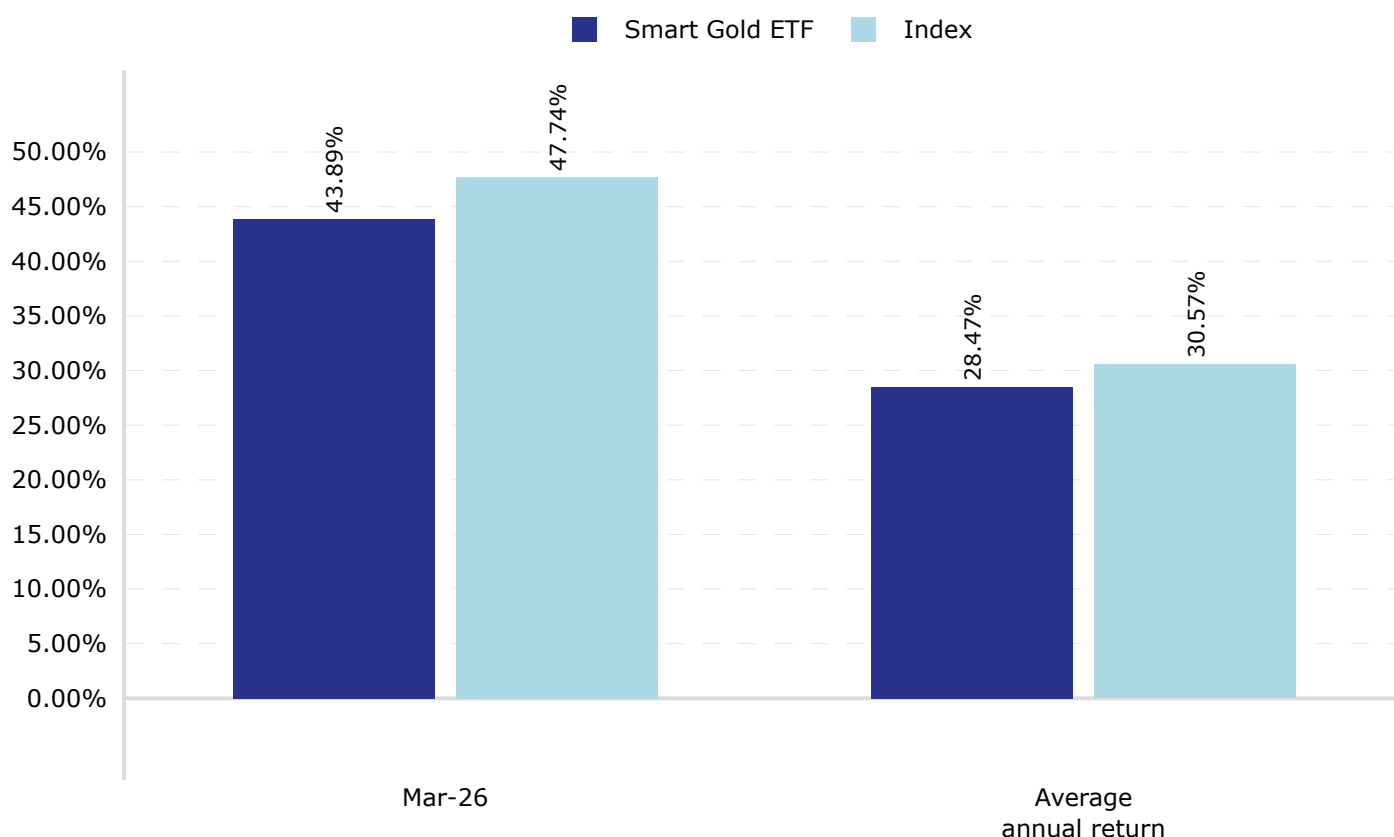

What fees are investors charged?

Investors in the Smart Gold ETF are charged fund charges. In the year to 31 March 2026 these were:

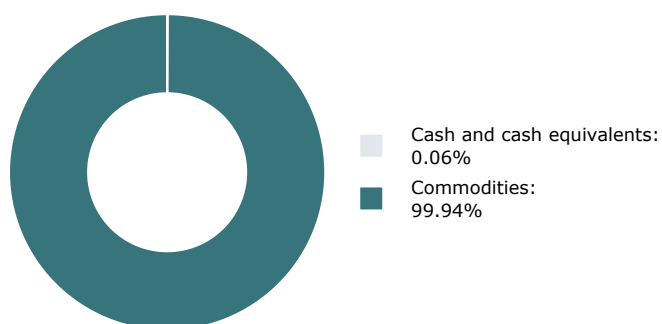
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$3,111 (that is 31.11% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,932 for the year.

Notes

1. Relevant index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 3 months of relevant index returns.
2. The annual return of the LBMA Gold Price PM USD (NZD) has been used as the relevant index because there is no appropriate market index for funds that invest into singular assets, such as gold. A relevant index may provide a less reliable indicator of future performance than an appropriate market index.
3. These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0.00% up to the total fund charges depending on the total value of the fund.
4. The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
