

Smart Total World (NZD Hedged) ETF

Fund update for the quarter ended 30 June 2026

This fund update was first made publicly available on 28 July 2026.

What is the purpose of this update?

This document tells you how the Smart Total World (NZD Hedged) ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

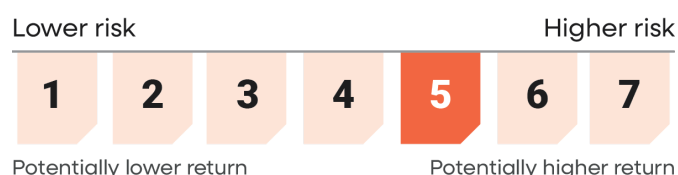
The Smart Total World (NZD Hedged) ETF is designed to track the return (before tax, fees and other expenses) of the FTSE Global All Cap Index (100% NZD Hedged). The Index is comprised of financial products of large, mid and small cap

companies located around the world. The currency exposure is hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Smart Total World (NZD Hedged) ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

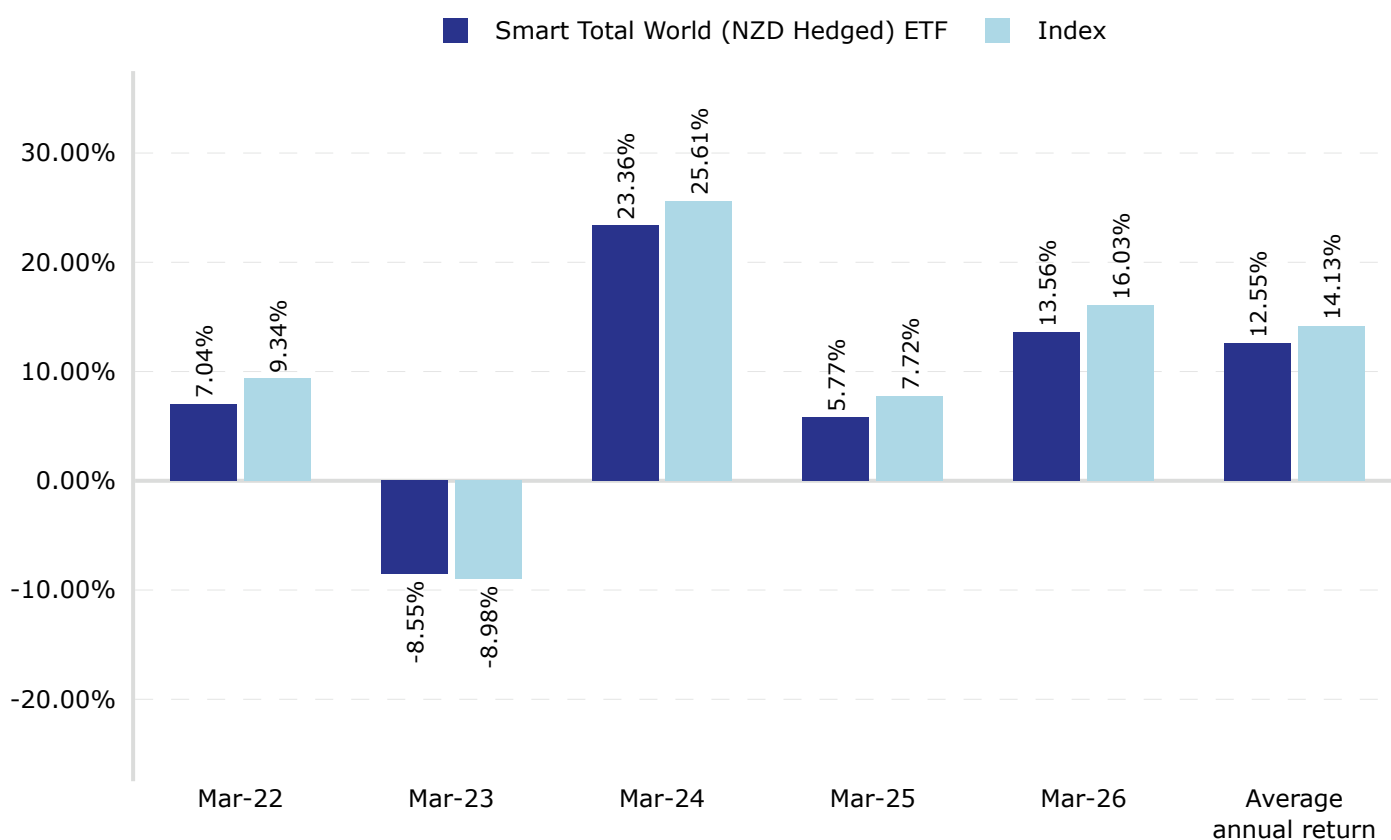

How has the fund performed?

What fees are investors charged?

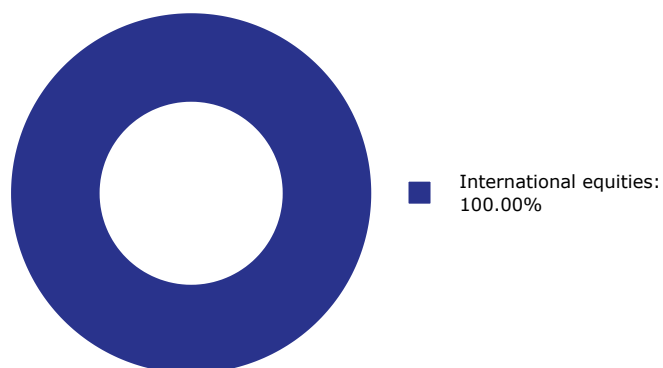
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,284 (that is 22.84% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,126 for the year.

Currency hedging

As at 30 June 2026 the fund's exposure to assets denominated in foreign currencies was 105.48%, of which 99.65% was hedged. This means the fund's unhedged foreign currency exposure was 0.37% of the net asset value of the fund.
