

Smart Australian Property ETF

What is the purpose of this update?

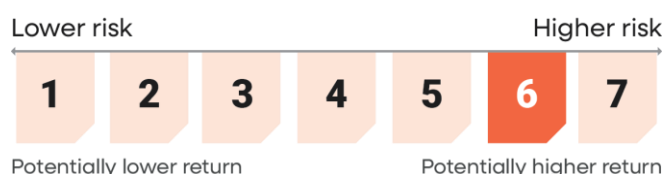
Description of this fund

The Smart Australian Property ETF is designed to track the return (before tax, fees and other expenses) of the S&P/ASX 200 A-REIT Equal Weight Index. The Index equally weights the constituents of the S&P/ASX 200 A-REIT Index, which is comprised of Australian Real Estate Investment Trusts (A-REITs) and mortgage REITs.

What are the risks of investing?

Risk indicator for the Smart Australian Property ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

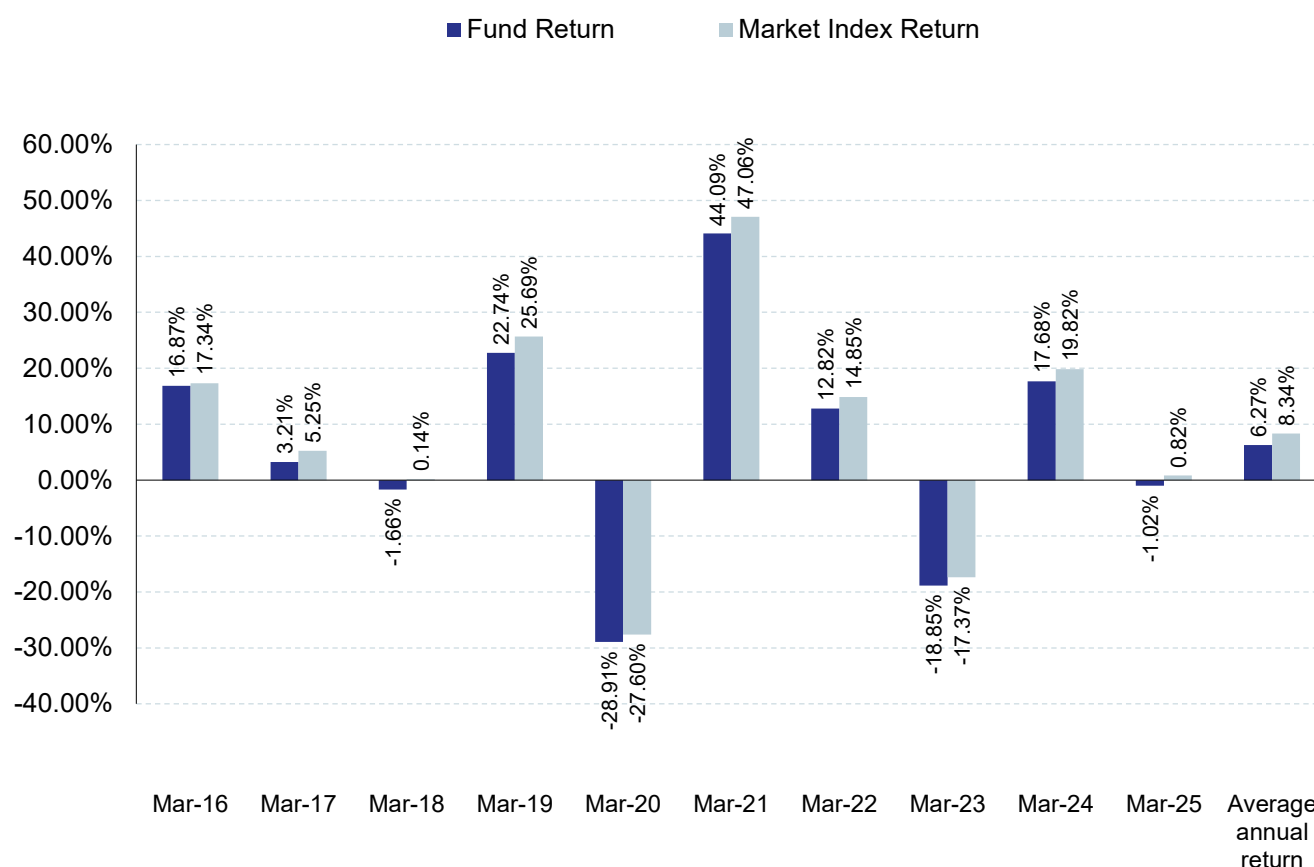

How has the fund performed?

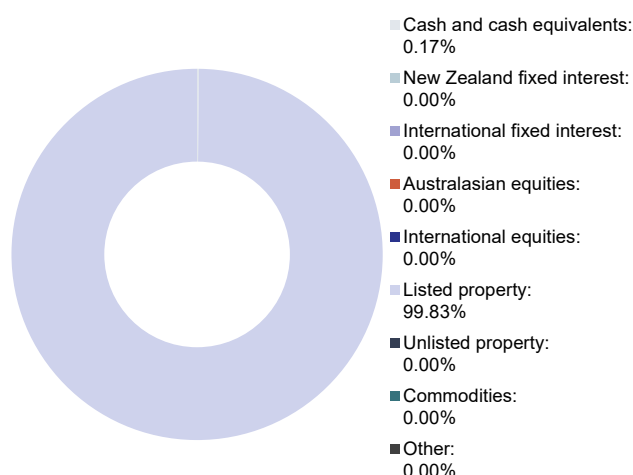
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,485 (that is 14.85% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,344 for the year.
