

# Smart Automation and Robotics ETF

## What is the purpose of this update?

This document tells you how the Smart Automation and Robotics ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. ## Description of this fund

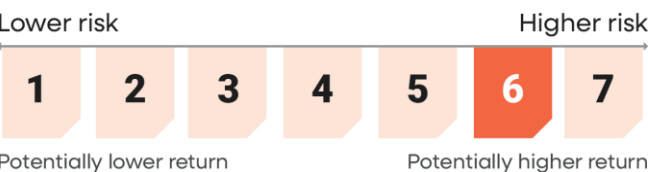
The Smart Automation and Robotics ETF is designed to track the return (before tax, fees and other expenses) of the STOXX® Global Automation & Robotics Index. The Index is comprised of stocks from developed and emerging market companies from sectors

associated with the development of automatic and robotic technology.

## What are the risks of investing?

### Risk indicator for the Smart Automation and Robotics ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

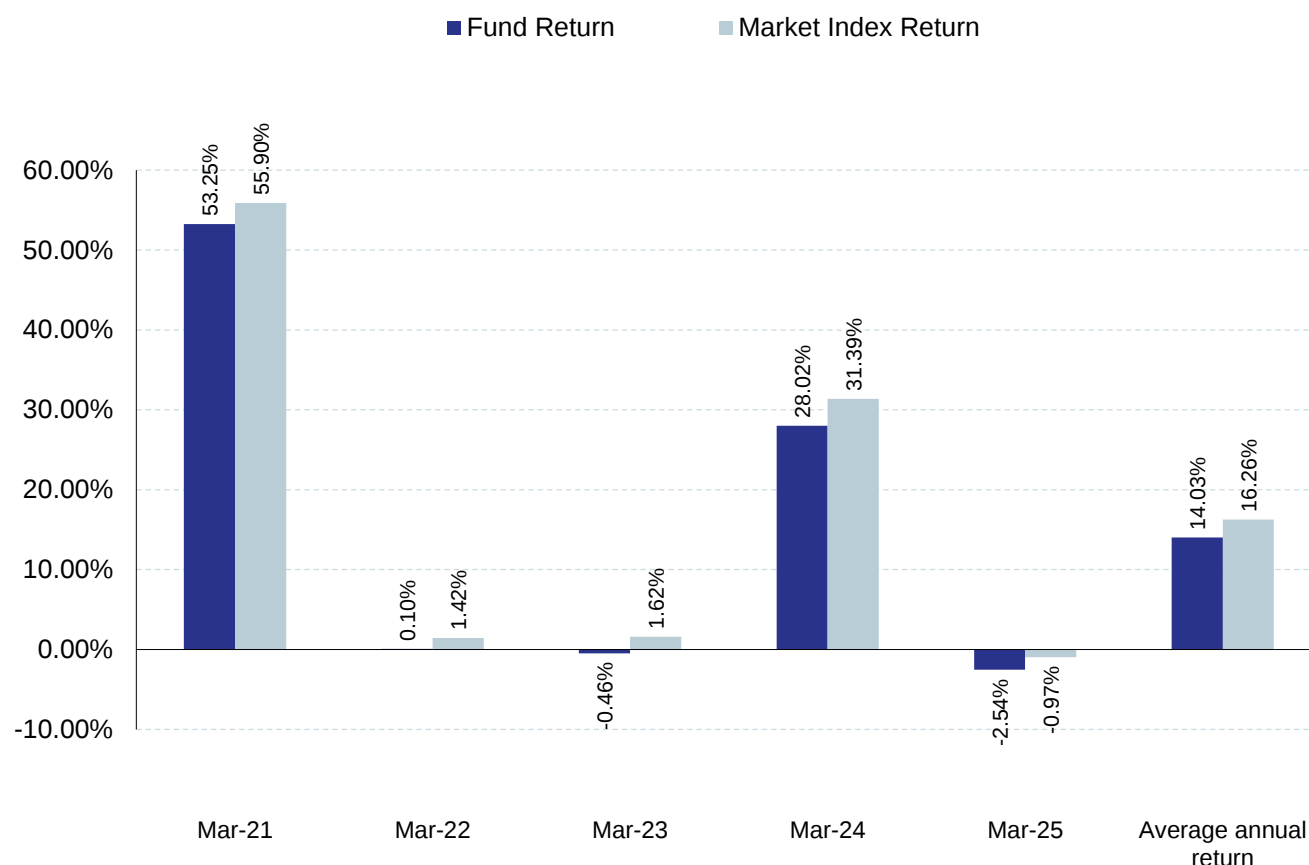

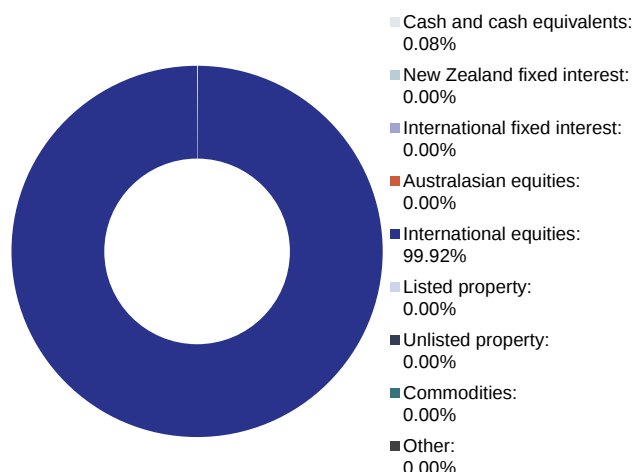
## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,658 (that is 26.58% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,494 for the year.
