What are the risks of investing?

Example of how this applies to an investor


Tara had \$10,000 in the fund on 24 October 2024 and did not make any further contributions. On 30 September 2025, Tara received a return after fund charges were deducted but before tax of \$348 (that is 3.48% of Tara's initial \$10,000). This gives Tara a total return after tax of \$255 for the period.

Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 1 month of market index returns.
- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
