

Smart NZ Mid Cap ETF

What is the purpose of this update?

This document tells you how the Smart NZ Mid Cap ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. 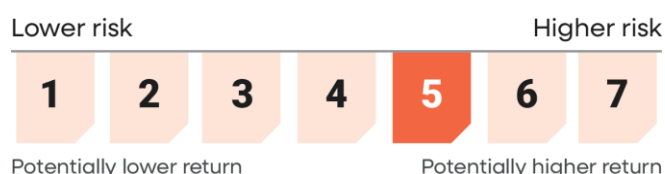
Description of this fund

The Smart NZ Mid Cap ETF is designed to track the return (before tax, fees and other expenses) of the S&P/NZX MidCap Index. The Index is comprised of companies listed on the NZX that are included in the S&P/NZX 50 Index but are not included in the S&P/NZX 10 Index.

What are the risks of investing?

Risk indicator for the Smart NZ Mid Cap ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

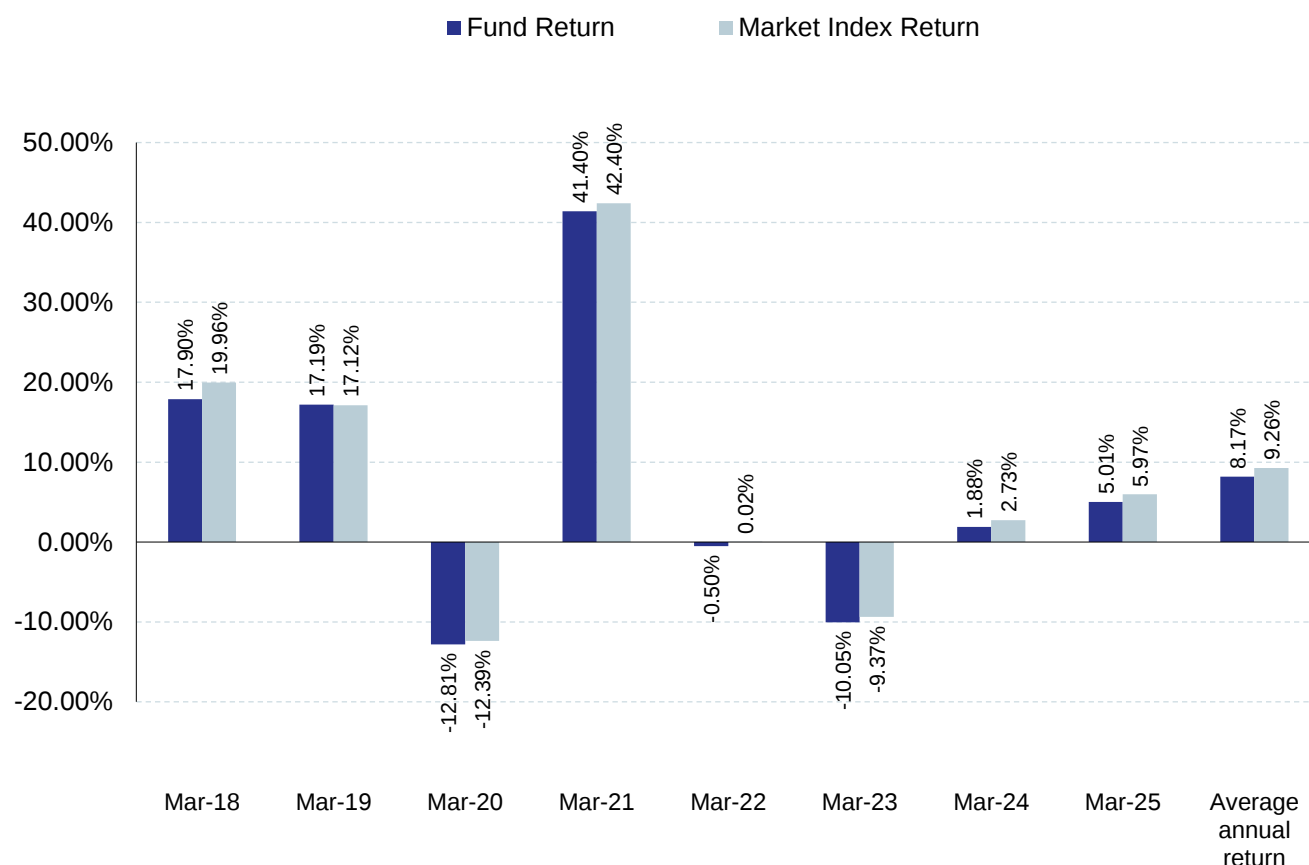

How has the fund performed?

What fees are investors charged?

Investors in the Smart NZ Mid Cap ETF are charged fund charges. In the year to 31 March 2025 these were:

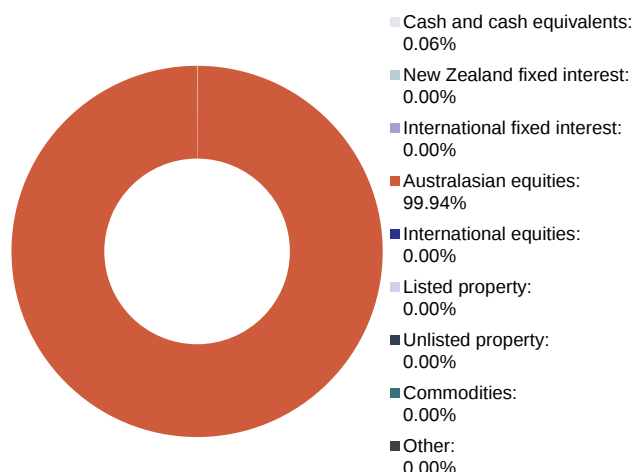
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,990 (that is 19.90% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,877 for the year.
