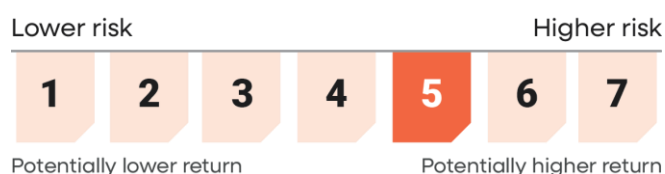
Description of this fund

The Smart Emerging Markets ETF is designed to track the return (before tax, fees and other expenses) of the FTSE Emerging Markets All Cap China A Inclusion Index. The Index is comprised of large, mid and small cap companies located in emerging markets around the world.

What are the risks of investing?

Risk indicator for the Smart Emerging Markets ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

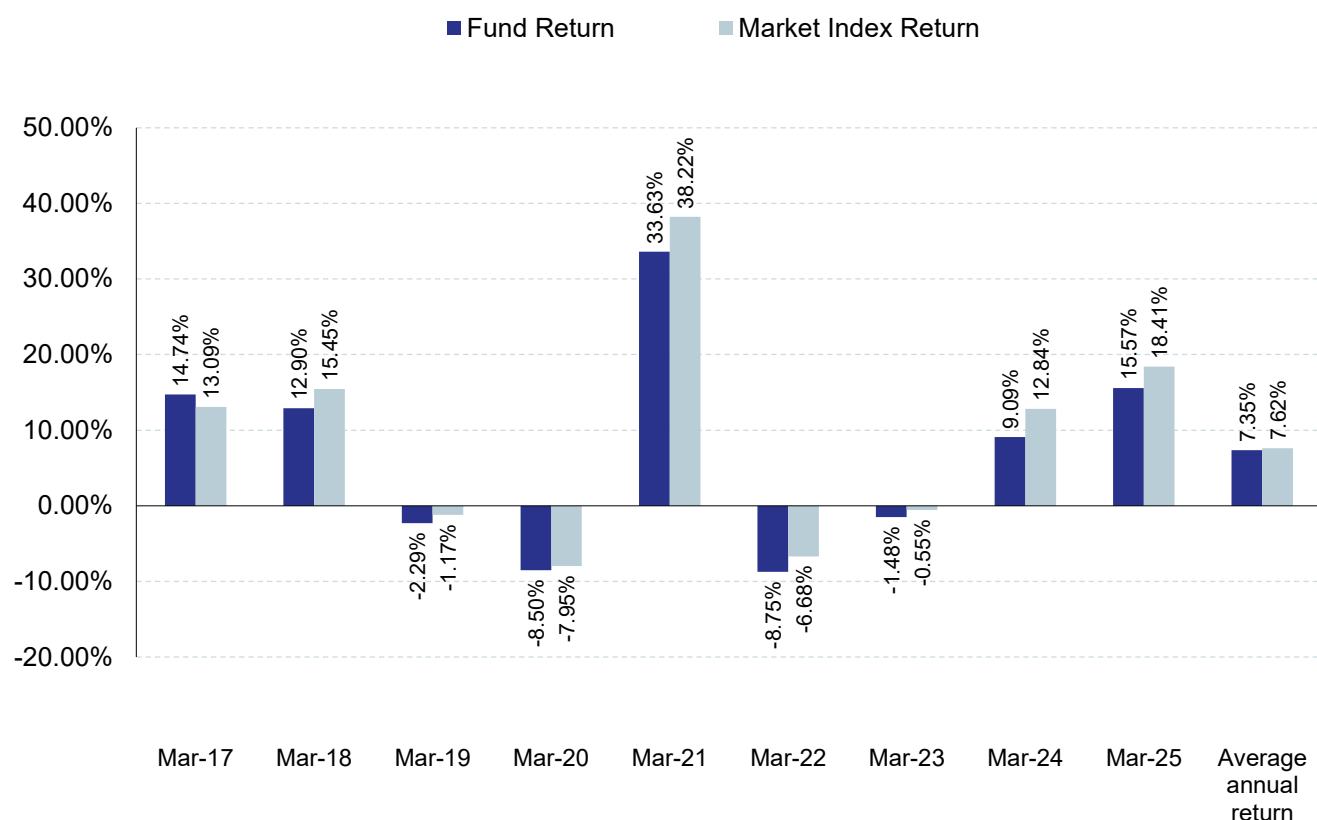

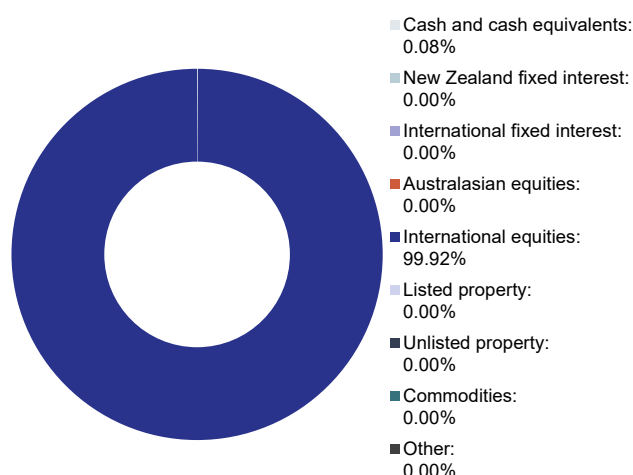
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,643 (that is 26.43% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,485 for the year.
