

## Smart S&P/NZX 20 ETF

### Fund update for the quarter ended 31 March 2026

This fund update was first made publicly available on 1 May 2026.

### What is the purpose of this update?

This document tells you how the Smart S&P/NZX 20 ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. 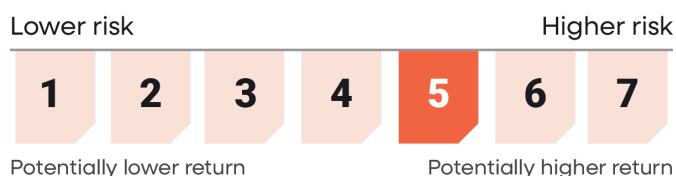
### Description of this fund

The Smart S&P/NZX 20 ETF invests in New Zealand shares and is designed to track the return of the S&P/NZX 20 Gross with Imputation Index.

### What are the risks of investing?

#### Risk indicator for the Smart S&P/NZX 20 ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

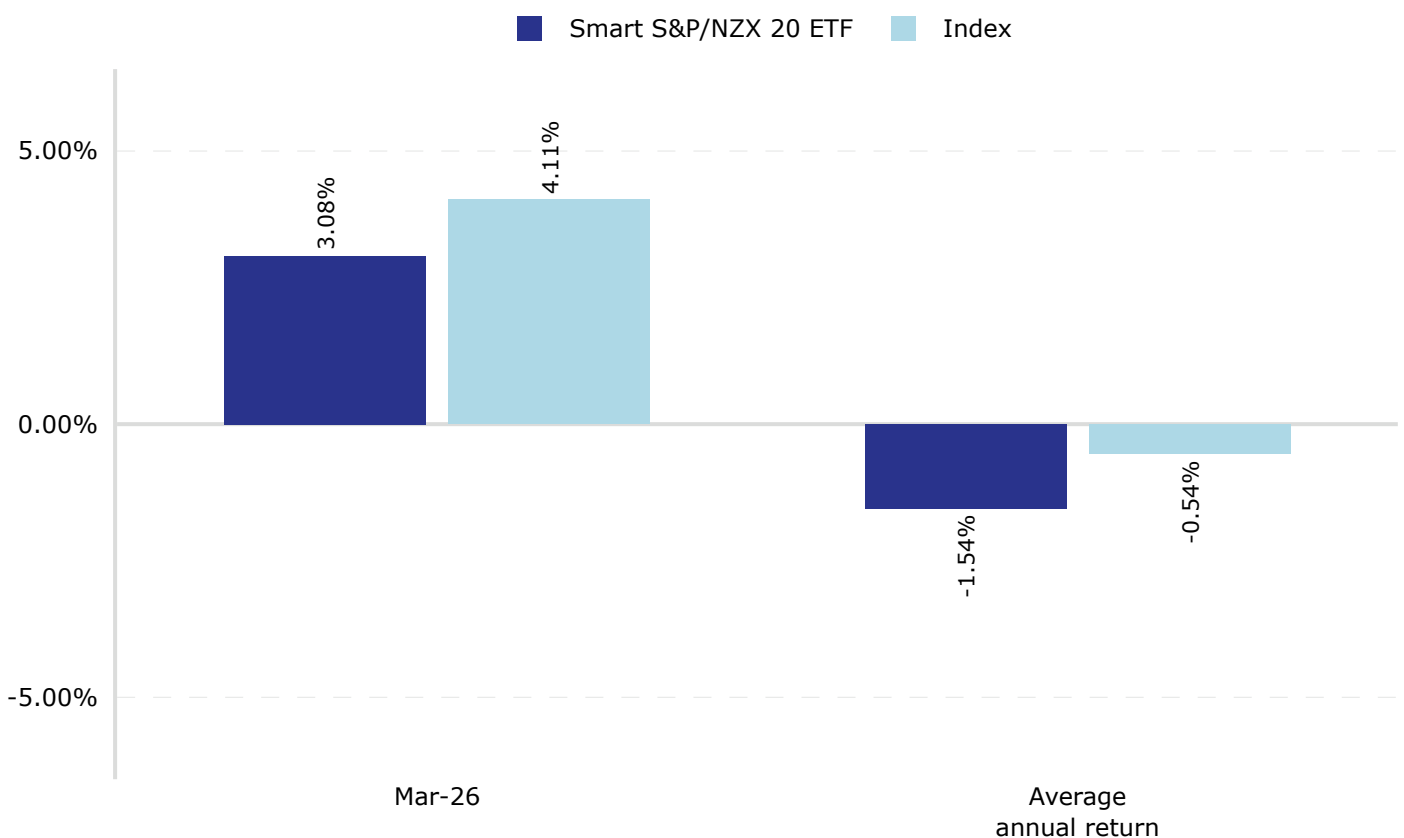

## What fees are investors charged?

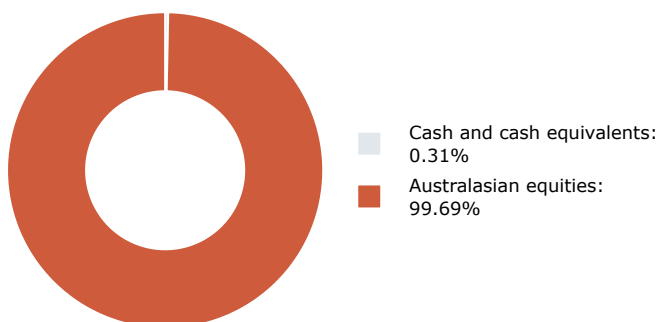
## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$398 (that is 3.98% of Tara's initial \$10,000). This gives Tara a total return after tax of \$308 for the year.

## Notes

1. Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 6 months of market index returns.
2. These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0.00% up to the total fund charges depending on the total value of the fund.
