June 2026



June 2026 overview

- » The Customer business recorded:
 - Mass market electricity and gas sales of 495GWh (June 2025: 410GWh)
 - Mass market netback of \$141.18/MWh (June 2025: \$146.32/MWh)
- » The Wholesale business recorded:
 - Contracted wholesale electricity sales, including that sold to the Customer business, totalled 1,056GWh (June 2025: 810GWh)
 - Electricity and steam net revenue of \$175.68/MWh (June 2025: \$186.08/MWh)
 - Electricity generated (or acquired) of 1,101GWh (June 2025: 846GWh)
 - Unit generation cost, which includes acquired generation was \$38.16/MWh (June 2025: \$54.27/MWh)
 - Own generation cost in the month of \$26.28/MWh (June 2025: \$47.27/MWh)
- » Otahuhu futures settlement wholesale price for the 4th quarter of 2026 (ASX):
 - As at 17 July 2026: \$45.55/MWh
 - As at 30 June 2026: \$62.6/MWh
 - As at 29 May 2026: \$77.5/MWh

- » As at 16th July 2026, South Island controlled storage was 145% of mean and North Island controlled storage was 123% of mean.
 - » As at 16th July 2026, total Clutha scheme storage was 147% of mean.
 - » Inflows into Contact's Clutha catchment for June 2026 were 171% of mean (May 2026: 89%, April 2026: 123%, March 2026: 85%).
- » Contact's contracted gas volume (including contracted swaps) for the next 12 months is 7.8PJ.
- » Contact's current renewable development projects under construction:

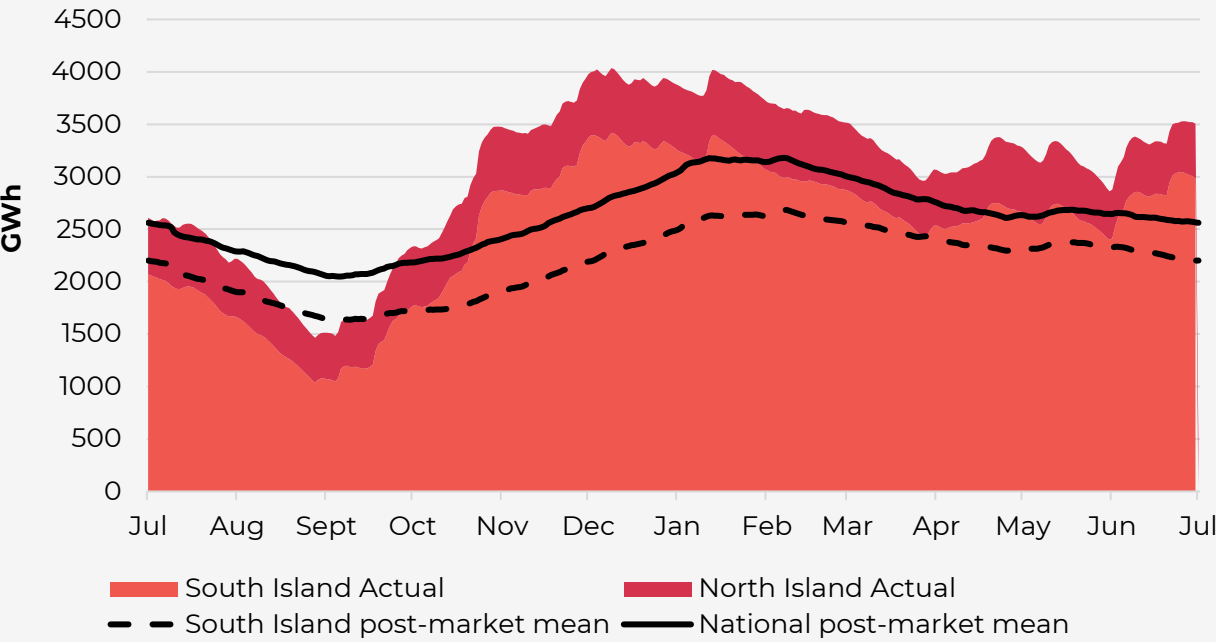

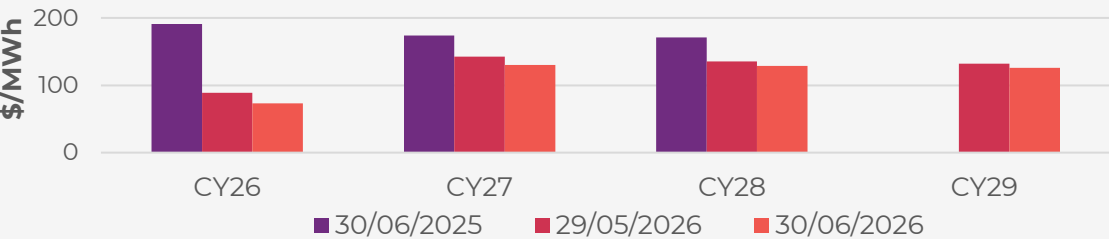
Hydro storage and forward prices

against mean / 12 months

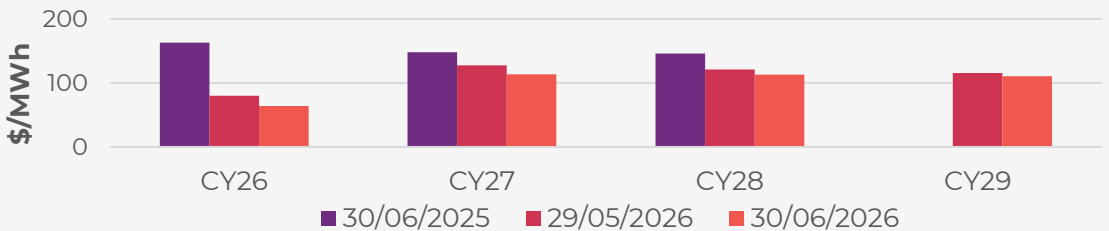

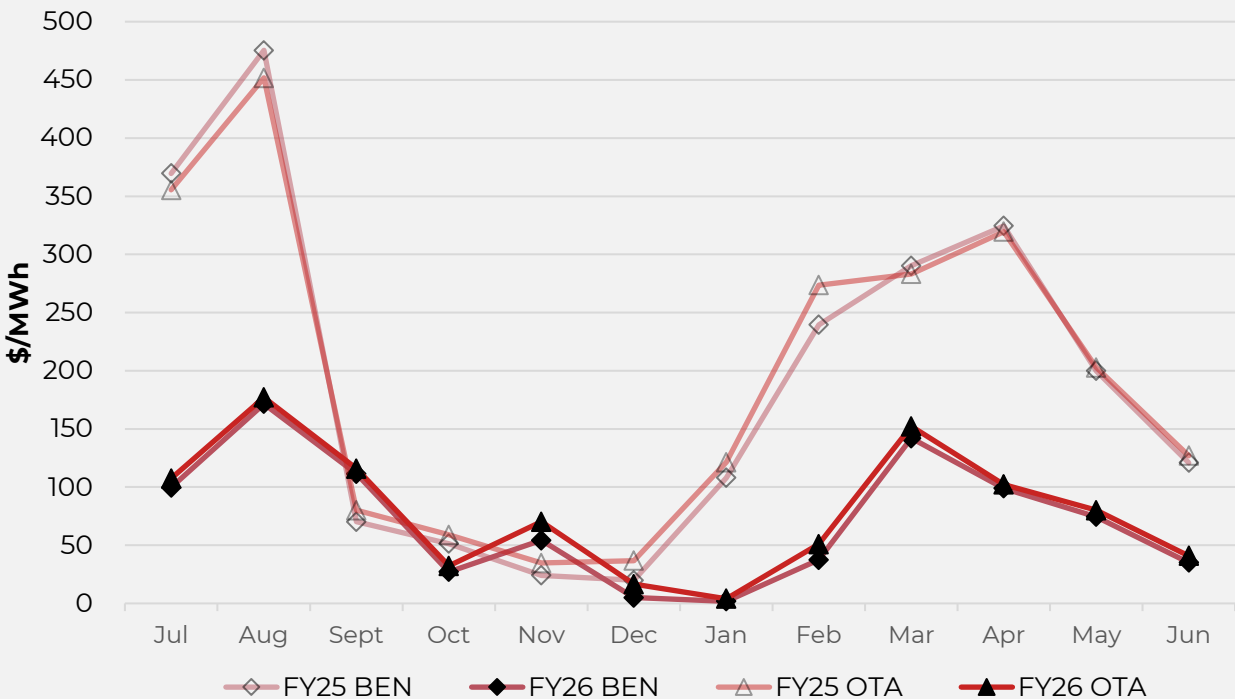

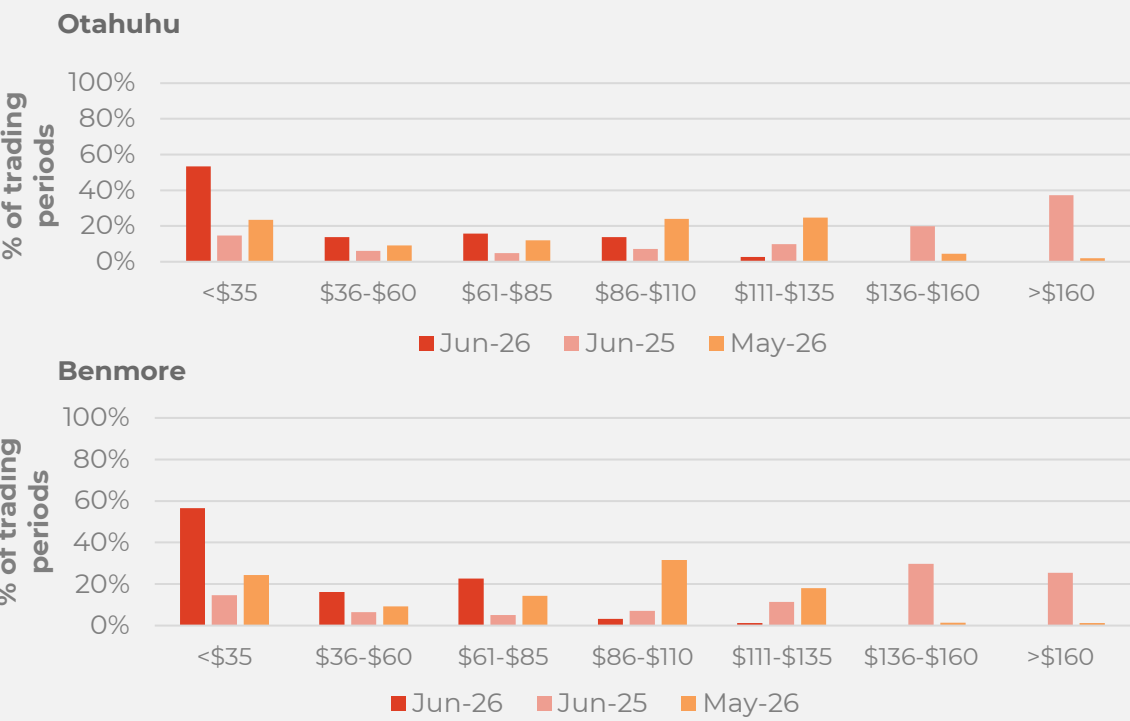

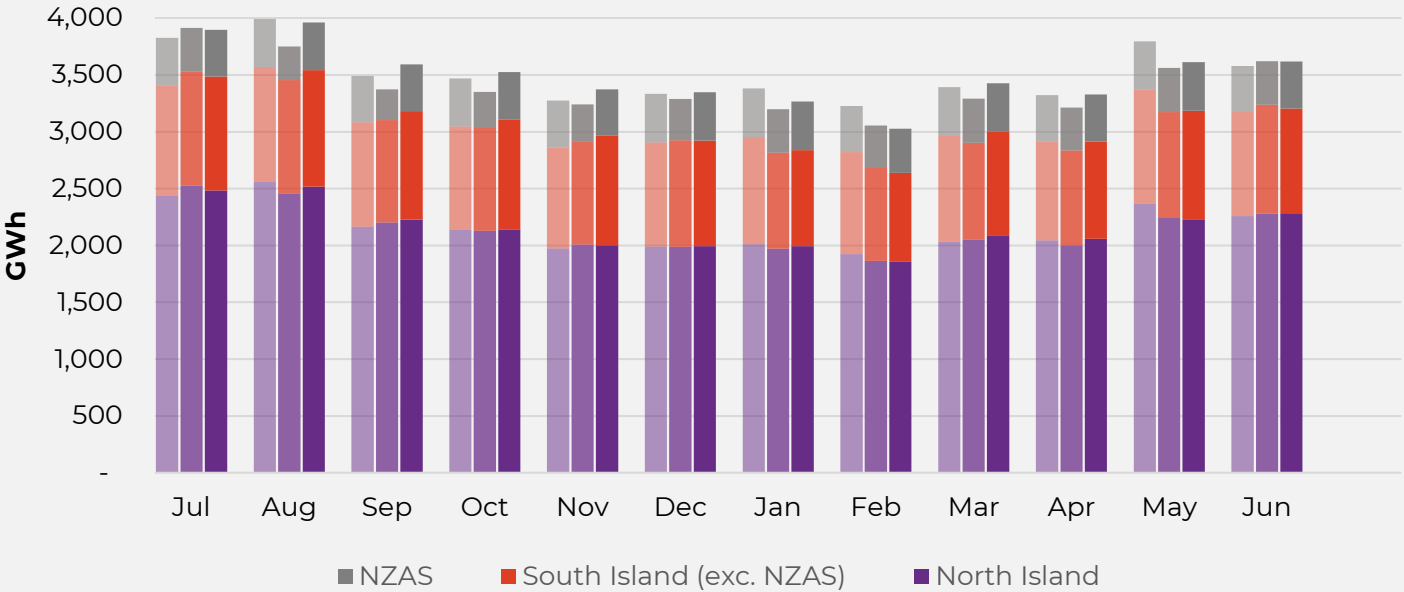
Distribution of wholesale market price by trading periods

FY24, 25 and 26 respectively

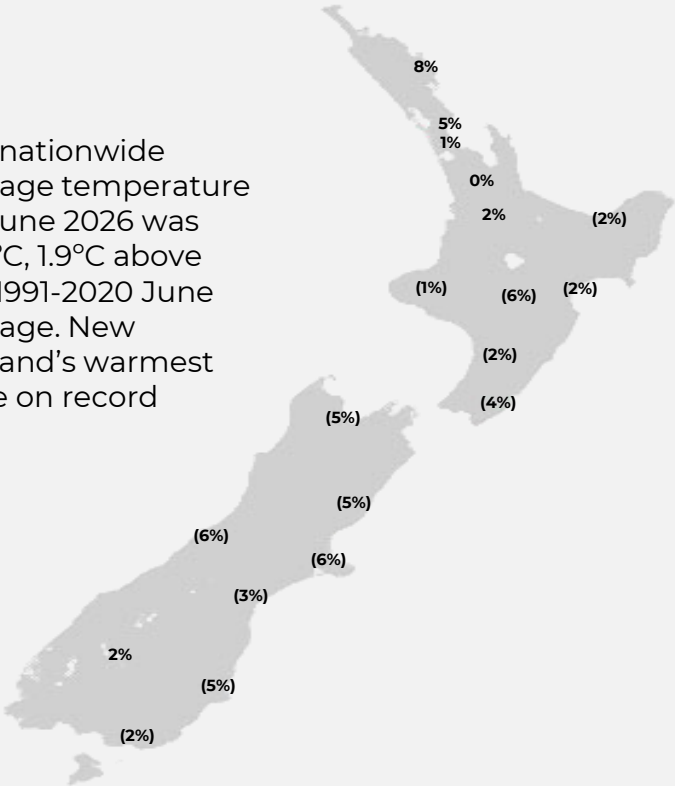


» New Zealand electricity demand was down 0.04% on June 2025. When compared to June 2024, demand was up 1.1%.

The nationwide average temperature for June 2026 was 10.6°C, 1.9°C above the 1991-2020 June average. New Zealand's warmest June on record

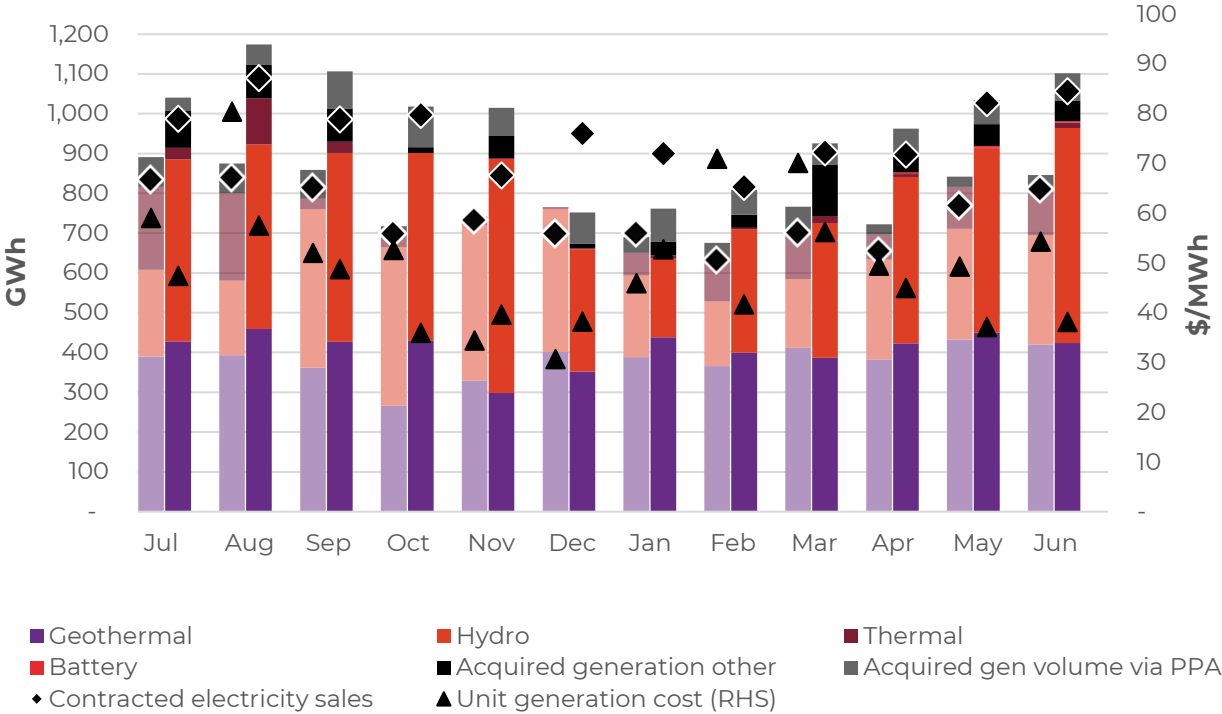

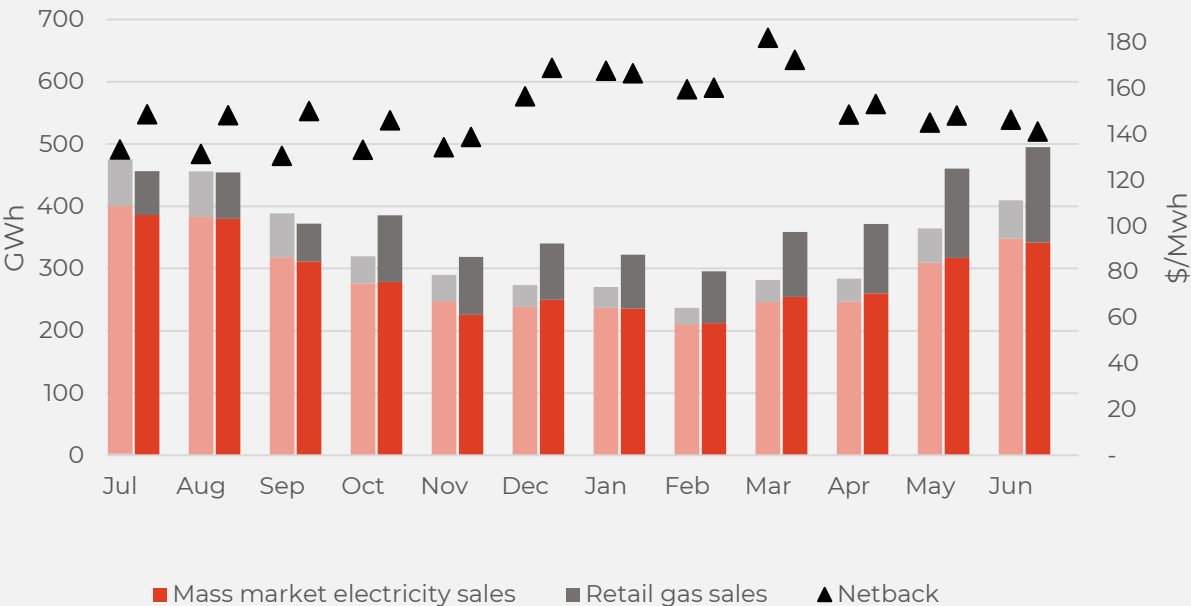

Note: In FY26, Contact incurred \$26.0m of costs associated with the acquisition of Manawa, including \$13.6m of transaction costs and \$12.4m of integration costs. Of the \$26.0m total, \$1.4m was incurred within the business units and has been reported within the cost lines of the monthly operating reports, and \$24.6m was within unallocated (corporate) costs.
