Details of transactions and events giving rise to relevant event

On 8 and 9 August 2026, Mangawhai entered into lock-up deeds (each a "**Lock-Up Deed**") with 13 of Bremworth's shareholders (together, the "**Accepting Shareholders**") in relation to the fully paid ordinary shares ("**Shares**") in Bremworth held or controlled by the Accepting Shareholders and their related trusts and entities. Copies of each of the Lock-Up Deeds were attached to the substantial product holder notice filed by Mangawhai with NZX on 9 August 2026.

Subject to certain conditions set out in the Lock-Up Deeds, each Accepting Shareholder agreed to accept (or procure the acceptance of) the Mangawhai partial takeover offer for all Shares in Bremworth that they or their relevant related trusts or entities own or control.

On 4 September 2026, Mangawhai made a partial takeover offer for 43.93667% of the Shares in Bremworth that it does not already hold or control (the “**Offer**”). A copy of the offer document for the Offer dated 4 September 2026 was provided to NZX on that date.

Since Mangawhai’s previous disclosure, and as at the end of the day on 20 September 2026:

- (a) Accepting Shareholders have accepted the Offer in respect of 11,491,663¹ further Shares in Bremworth subject to the Lock-Up Deeds. Accordingly, for the purposes of section 278 of the Financial Markets Conduct Act 2013, the nature of Mangawhai’s relevant interest in those Shares has changed; and
- (b) other Bremworth shareholders have accepted the Offer in respect of 1,355,936 further Shares in Bremworth.

Mangawhai’s relevant interest in 1,678,467 Shares in Bremworth arising from the Lock-Up Deeds with those Accepting Shareholders that have yet to accept the Offer remains unchanged.

As at the end of the day on 20 September 2026, Mangawhai has a relevant interest in respect of, in aggregate, 42,613,647.1681 Shares in Bremworth.

- (d) In respect of 27,301,338 ordinary shares in Bremworth: A conditional power to acquire quoted voting products upon the Offer becoming unconditional in all
