On 27 July 2026, Sena & Co made a full takeover offer for all of the ordinary shares in 2CC (**Shares**) not already held by Sena & Co (the **Offer**). A copy of the Offer accompanied a disclosure made to 2CC and NZX on 27 July 2026.

Since its previous disclosure, Sena & Co has received, as of 5.00pm on 22 September 2026, acceptances under the Offer in relation to a further 1,359,679 Shares. If settlement occurs in accordance with the Offer, Sena & Co will become the registered holder and beneficial owner of 5,705,914 Shares, in addition to the 34,586,927 Shares currently owned by Sena & Co.
